A Year After Dobbs, California Leads in Protecting Women's' Reproductive Health

On June 24, 2022, the U.S. Supreme Court struck down Roe v. Wade and 50 years of constitutional protection for the right to an abortion in its decision in Dobbs v. Jackson.

At the time of the Court's 1973 decision in Roe v. Wade, 30 states prohibited abortions. In the wake of the Dobbs decision, 14 states now ban abortion with very limited exemptions.

California has reacted forcefully to protect women's rights in health care and specifically reproductive freedom. In response to questions to the Newsom administration, Julia Spiegel, who serves as Senior Advisor for Reproductive Rights issued the following statement:

"Governor Newsom has long championed reproductive rights. In the last year alone, the Governor launched an Alliance of 22 governors to protect reproductive freedom across the country, helped enshrine the right to abortion in the state constitution, and signed into law more than a dozen bills expanding access to care and protecting those who provide, access, and support that care.

The right to reproductive freedom is not bound by borders. That's why the Governor signed several laws aimed at ensuring anyone in California who needs reproductive health care can get it. And California is protecting medical and other data so that other states cannot reach into ours to try to prosecute those who come here to lawfully access reproductive health care."

One of the state's most important efforts is The Reproductive Health Initiative managed by the Department of Health Care Access and Information (HCAI). Shelley Rouillard, who heads the program, is the former director of the Department of Managed Health Care.

Cynthia Baker:

A Lifetime of Civic Responsibility

In a recent interview, Cynthia Baker recounted her mother's participation in the historic lunch counter sit-ins at Woolworth's and other department stores. In 1960, Baker, who was then a college student in her hometown of Savannah, GA, knew her mother was a civil rights activist joining others across the South, openly defying



Jim Crow laws, including those banning Blacks from eating at the same places as white customers.

Her mother's commitment to community service and political activism was reinforced by teachers at the segregated junior high school Cynthia attended. It was there that she learned about the importance of voter registration. That same year, she witnessed a white store clerk refuse to help a Black man fill out a money order. Cynthia said she stepped in and helped the man complete the money order. In the mid-1950's, as a high school student, she also helped Black citizens register to vote – an act that cost some civil rights workers their lives.

Cynthia furthered her education at Savannah State College, studying to become a teacher. As a sophomore, she joined the Student National Education Association which focused on improving the education of Black students in the public schools. In her senior year, she was elected the state president of the Association and traveled to many cities speaking with state legislators in support of bills supporting public education.

After graduating college, Cynthia started teaching in Ft. Walton Beach, FL. After the assassination of Dr. Martin Luther King Jr in 1968, she moved to Sacramento with her husband and daughter. Baker taught in the San Juan School District for 26 years and was a member of the San Juan Teachers Association serving one term as its vice president. She played a key role in lobbying for public education and served as a contact for Congressman Vic Fazio and Senator Alan Cranston, both national leaders in the Democratic Party. She traveled to Washington, D.C. over 20 times to lobby in support of federal funds for education.

After retiring in 1996, Cynthia participated in several Democratic Party clubs in the Sacramento area, including the Town and Country Democrats. She has been a member of the Women Democrats of Sacramento County since 2017.

The \$120 million initiative is part of a package signed into law in 2022 and is composed of five programs.

Clinical Infrastructure (\$20 million)

HCAI is establishing and administering clinical infrastructure scholarship and loan repayment programs to expand the number of healthcare providers offering abortions, abortion-related care and reproductive health services.

Rouillard said, "These funds will go to health care professionals and students who agree to practice in reproductive health for between one to three years depending on the program. Its physicians, nurses, nurse midwives, licensed vocational nurses, registered nurses, and community health workers--the whole range of providers," she added.

Capital Infrastructure (\$20 million)

This grant program will focus on enhancing physical and digital security infrastructure for health care facilities and reproductive health care practitioners who provide abortion-related care and reproductive health services in California.

Uncompensated Care Fund and Abortion Practical Support Fund (\$60 million)

• The Uncompensated Care Fund (\$40 million) will provide grants to health care providers who deliver abortion and abortion-related care to very low-income individuals and do not have coverage for such services.

This edition of the Women Dems newsletter is dedicated to women's lives and our fight for reproductive rights! The "War on Women" is appalling. Laws are being enacted by states with reckless disregard for the wellbeing of women. How can anyone say they are "Pro Life" when that



means a woman is likely to die of medical complications caused by a non-viable pregnancy? How is it acceptable laws are being created without sufficient input from medical experts while tying the hands of physicians providing care to their patients?

Roughly half the states across the country are throwing everything into laws banning abortion including murder charges, travel restrictions preventing women from going out of state for counseling or procedures, and bringing charges against physicians performing abortions while threatening to suspend their licenses. And keep in mind, the federal judge in Texas who ruled the Food and Drug Administration's approval of Mifepristone--one of two drugs necessary for medical abortions--was improperly approved and advocates the end of it being prescribed in the United States.

While we live in a relatively safe and sane state, we must not stand idle and remain silent as we witness what is happening to women across the nation. •

• The Abortion Practical Support Fund (\$20 million) will provide grants to non-profit organizations to help individuals seeking abortion care with the supports necessary to access abortion-related care. The fund covers people traveling within California and those from out of state. Practical support can include travel, lodging, childcare, food, etc.

CA Reproductive Health Services Corps (\$20 million)

The Corps aims to recruit, train, retain, and financially support a diverse workforce of health care professionals who commit to providing reproductive health services, including abortion care, for at least three years.

Its focus will be on physicians who aren't trained in performing abortions or abortion-related care, such as those in family practice and internal medicine. # # #

TOWN HALL WITH REP. KATIE PORTER Hosted by the Women Democrats of Sacramento County

Congresswoman Katie Porter, one of three candidates running to succeed retiring U.S. Senator Dianne Feinstein, was the featured speaker at a town hall meeting organized by the Women Dems on June 10.

More than 100 people gathered in the middle of Pride Weekend to be introduced to and ask questions of Porter, who won a very tough re-election campaign in Orange County.

As one of the more astute members of the House Oversight Committee, Congresswoman Porter often uses a whiteboard in committee hearings in her opening statements or questioning of witnesses. She was introduced by our President, Sandra Hazel using a whiteboard to highlight Porter's accomplishments as an attorney and a member of Congress

She spoke first about the challenges of being the only single mother with children in Congress. Porter also reflected on her current campaign and was gracious in her comments about Congressman Adam Schiff from Los Angeles and Congresswoman Barbara Lee from Oakland with whom she is competing for the Senate seat.

Porter also focused on her concerns about the lending practices and stability of financial institutions and a number of issues concerning large corporations, some of the key issues she has addressed as a member of the Oversight Committee.

Porter kept her remarks brief to allow more time for the questionand-answer session. Adults and students asked questions ranging from immigration and homelessness to environmental protection and climate change.

The event took place at St. Andrew's AME Church, the oldest African American church west of the Rockies, established in 1850.

Special thanks to Anna loakimedes, our Political Affairs Director, for working with the Porter campaign to organize the town hall. The Women Dems are working to arrange town hall meetings with the other candidates running for the Senate seat.

Our Speaker Series for April focused on Autism Awareness Month. Our guests were Dave Gaines, CEO of Sacramento Autistic Spectrum & Special Needs Alliance (SASSNA), and Christine and Dale Baquiran, parents of a child with autism.

Gaines described the services his organization provides to children and their families through case management, advocacy, social and recreational events, and resource assistance. He works with families assisting them to ensure their children receive educational services, government services, employment services and meeting other needs. Christine and Dale Baquiran provided a glimpse of their life as parents of a daughter who is on the autistic spectrum. As both a registered nurse and public health nurse, Christine recognized early indicators that their daughter's behavior might be autistic. Dale and she had to become advocates to be heard by doctors in addition to pushing to get the correct testing needed to properly diagnose their daughter. They shared not only some of the daily challenges that come with having a child with autism but also some of their greatest rewards as parents.



May

Gun violence was our May Speaker Series topic. Our guests were Dr. Bill Durston, co-founder and President of Americans against Gun Violence, and Cynthia Shallit, member of Moms Demand Action and a member of Women Dems.

After retirement, Cynthia Shallit became interested in national politics in the aftermath of the Parkland high school shooting in February 2018. She became active in grassroots organizing and lobbying as the national chapters of Moms Demand Action focused on strengthening gun safety laws developed and enacted by state legislatures. The organization also supports candidates who advocate tougher gun laws and it petitions schools to educate parents on the proper storage of weapons in the home. Dr. Bill Durston is a board-certified emergency physician who has treated innumerable civilian gunshot victims during a medical career spanning more than 40 years. Before becoming a physician, Dr. Durston served in combat with the U.S. Marine Corps during the height of the Vietnam War.

Dr. Durston's organization, Americans against Gun Violence advocates the following:

- The enactment of stringent gun control regulations in the U.S., comparable to longstanding laws and regulations enforced in every other high income democratic country in the world, and
- 2. To overturn the 2008 Supreme Court's decision in *District of Columbia v. Heller*. The "Heller Decision" stated Washington D.C.'s partial handgun ban violated an individual's right to gun ownership according to interpretations of the Second Amendment. *Heller* was the first Supreme Court case to decide whether the Second Amendment protects an individual's right to bear arms for self-defense or whether the right is solely intended to service a "wellregulated militia."

We used our extra time to write postcards to young, democratic-leaning women in Ohio encouraging them to vote "NO" on Issue 1. This ballot initiative would change the threshold for approval of constitutional amendments from a simple majority to 60 percent of those voting. It would make it more difficult for future citizen-led amendments on issues including abortion access to pass. A total of 82 postcards were completed by approximately 24 attendees. The Historic Federal Climate Bills and You

Members, Sacramento/Roseville Chapter of the Citizen's Climate Lobby. CCL is a nonpartisan, non-profit, grassroots advocacy organization focused on national policies to address climate change.

In 2021 and 2022, Congress passed significant climate change legislation and dedicated more dollars to fighting climate change than at any point in U.S. history. More than \$500 billion to counter climate change was included in three bills: the CHIPS and Science Act, the Infrastructure and Jobs Act, and the Inflation Reduction Act (IRA). The 2030 deadline imposed by these new laws could cut U.S. greenhouse gas emissions 40 percent from what their levels were in 2005.

Projects funded by this new legislation include building a system of nationwide

charging stations for electric vehicles and incentives to encourage utilities to use non-fossil fuel energy sources. The new laws also will spur domestic "green manufacturing" leading to development and production of new technologies to capture alternative energy sources (wind, solar, etc.). There also are incentives for consumers to make their homes more energy efficient and subsidies for the purchase of electric vehicles.

There is still work to be done in Congress concerning permitting reform. Some concessions likely will have to be made to energy companies for new exploration. At the same time, however, the federal permitting process must be streamlined for construction of faster and more efficient transmission lines to bring electricity to where it is needed. There already are signs the three bills have begun stimulating economic growth and creation of good, well-paying jobs. The efficient use of electricity in private homes will help us achieve our climate goals. And permitting reform will enable a modernized and upgraded national power grid allowing the U.S. to move toward a healthier future assisted by renewable energy.

The Republican War to Topple Female Freedom State-by-State

A good friend of mine, who moved from Sacramento to Missouri, has said that the 2018 election of Josh Hawley to the U.S. Senate was "a sign of the GOP antiwoman agenda." We all remember Hawley saluting the noose-bearing insurrectionists on Jan 6th. Now Hawley's book, *Manhood, Masculine Virtues America Needs*, displays his assertion that courage, independence, loyalty, and boldness are chiefly male attributes. Slated to speak in May at a conservative church "Manstravaganza"

(where monster trucks and bull riding would be on display), Hawley likely was not queried about the video of him running away from the mayhem inside the Capitol on the very day he saluted it.

Another GOP manhood aficionado is Tucker Carlson, recently canned by Fox News. Carlson, who at one point complained about the 'masculine' appearance of the shoes worn by Disney's Minnie Mouse, is marching in the GOP manhood crusade. He once invited a bizarre physical therapist to his show to promote a testicle tanning device. This was predicated on the belief that bronzed testicles are more manly. Nothing is too frivolous, possibly unhealthy, or weird for the Republican manhood cult.

While these comic cosmetic occurrences were ongoing, the GOP began its real work—obliterating female reproductive freedom. Abortion is now completely banned with very limited exceptions in Alabama, Arkansas, Idaho, Kentucky, Louisiana, Mississippi, Missouri, North Dakota, Oklahoma, South Dakota, Tennessee, Texas, West Virginia, and Wisconsin.

These states will be joined by others. While the GOP manhood doctrine thrives, women's real reproductive rights and freedoms are being extinguished. In these states, female citizens are now subject to fascist dictums. These Americans can no longer make their own most deeply personal reproductive choices and punishments await those who try. Though they might be easily identified via DNA, no retribution awaits the men who participated in forced birth pregnancies.



Another anti-woman GOP crusade is the burgeoning war against no-fault divorce. Right wing podcaster Steven Crowder, who recently and publicly chastised his 8 months pregnant wife for not doing "wifely things," leads this movement to make it harder for a woman to escape an oppressive marriage. Remember, no-fault divorce adoption led to "dramatic drops in the rates of female suicide and domestic violence, as well as decreased "spousal homicide" of women. (Tessa Stuart,

"The Next Front in the GOP's War on Women," *Rolling Stone*, May 2023).


Finally, we have scowling Governor Ron DeSantis of Florida. Besides cruellv shipping immigrants to Washington D.C (as "a joke"), DeSantis is waging cultural war on what he calls the "woke mob"-gays, transgender citizens, and education itself. He doesn't want a school system that performs well. He also doesn't want Florida to turn out graduates who know the plain truth about history, sexism, structural racism, income inequality, threats to democracy, and forced religious observation. When you see a loutish, armed crowd raging outside a small library because it carries a copy of The Bluest Eye, by Toni Morrison, you're seeing DeSantis voters.

My friend in Missouri says, "You should care about this in California. The whole country's at risk." So, what we have here with "mansplaining" Josh Hawley, Tucker Carlson, Steven Crowder and Ron DeSantis is the Republican scheme to topple female freedom state-bystate.

They're easy to ridicule now, but one day a right-wing Republican who frets about Minnie Mouse's footwear could put your daughter in jail.

Summer Reading Picks for Women's Rights



I Swear: Politics is Messier than My Minivan by U.S. Representative Katie Porter (Available on: Audible, Kindle, and Hardcover)

This book is written in lively style reflecting both funny and serious times in Congresswoman Porter's life. First elected in 2018 in a very conservative district in Orange County, she also highlights the fact she is the only single mother with small children serving in Congress. Porter often is chided for her progressive values by other House members, but has established herself by holding powerful men accountable in congressional hearings and other settings.

Porter has been an attorney and professor of law and is a native of Fort Dodge, Iowa. She currently is one of three House members campaigning to succeed Sen. Dianne Feinstein, who has announced her retirement set for the end of 2024.



Lady Justice: Women, the Law, and the Battle to Save America by Dahlia Lithwick

(Available on: Audible, Kindle, and Hardcover)

Lithwick tells the gripping story of the women, who as attorneys, fought the racism, sexism, and xenophobia of Donald Trump's presidency - and won. It is a celebration of the tireless efforts, legal ingenuity, and indefatigable spirit of the women whose work all too often went unrecognized at the time.

She has been a legal commentator on MSNBC and brings her sense of humor to her writing while focusing the reader's attention on the federal court system, human rights, and specifically women's rights.



Dahlia Lithwick was born in 1968 in Ottawa, Canada. She is an attorney, writer, and journalist. Lithwick currently is a contributing editor at Newsweek and senior editor at Slate. She holds a bachelor's degree from Yale University, graduated from Stanford University, and was a clerk to one of the justices on the U.S. Court of Appeals -Ninth Circuit.



"We Should All Be Feminists" by Chiamanda Ngozi Adichie

This Ted^x Talk, available on YouTube, is about Women and Society. It was later published as an essay.

Adichie was born in the City of Enugu in Nigeria, Africa to an Igbo family. Her father, worked as a professor of Statistics at the University of Nigeria in Ugubu State. Adichie's education includes Eastern Connecticut University, Yale University and Johns Hopkins University. Her work includes novels, short stories and non-fiction.

In the Ted^x Talk, Ms Adichie explains what the word "Feminist" means to her and how we all can use the lesson that standing up for oneself can actually make modern society better. Her message was, "We teach girls that they can have ambition, but not too much... to be successful, but not too successful, or they'll threaten men." In this absolutely brilliant and classic talk that started a worldwide conversation about feminism, Adichie asks that we begin to dream about and plan for a different, fairer world -- of happier men and women who are truer to themselves.

Chimamanda Ngozi Adichie is an internationally acclaimed, best-selling author. Her novel, Half of a Yellow Sun, about the Nigerian Civil War, won the Bailey's Women's Prize, one of the world's most prestigious prizes for fiction. She also is a recipient of a MacArthur Foundation fellowship.
